The approval is valid for two years from the date of issue of this letter. The Society/Trust/Institution shall obtain necessary affiliation/ permission from the concerned affiliating University. as per the prescribed schedule of the University/ Admission Authority etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. Incase the Institution could not commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval becomes invalid and the applicant society/trust shall have to make fresh application to AICTE for grant of fresh approval.

The approval is further subject to fulfillment of following conditions.

- 1. That the management shall provide adequate funds for development of land and building and for providing related infrastructure, instructional and other facilities as per Council's norms and standards laid down by the Council from time to time and for meeting recurring expenditure.
- 2. (a) That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.

- () That the institution shall furnish requisite returns and reports as desired by AICTE in ler to ensure proper maintenance of administrative and academic standards.
- () That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/programmes being conducted and details of infrastructure facilities including faculty etc. in the form of mandatory disclosure.
